#### **Introduction**

ICAADA, a subsidiary of Mental Health America of Indiana, provides credentialing for behavioral health professionals. ICAADA provides behavioral health professionals with credentials, membership, and advocacy that validate the professionals' competencies to provide person-focused, evidence-based behavioral health services.

ICAADA was first formed In September 1973 by a group of dedicated and forward-looking substance use professionals. ICAADA started as an association of substance use professionals and people interested in the field. It was quickly decided there needed to be a process designed to establish a credential that would certify a person's competency relates to substance use treatment.


ICAADA is Indiana's longest tenured substance use certification organization. In 1976, with the cooperation of what was then the Department of Mental Health, Division of Addictions Services, ICAADA began the process of certification with the first credential being the Certified Alcohol Counselor (CAC). In 1977, a second credential, the Certified Drug Counselor (CDC), was established. In 1978, ICAADA established the Certified Alcohol & Drug Abuse Counselor (CADAC) credential (now known as the Certified Alcohol and Drug Addiction Consultant).

In 1979, a meeting was held in Merrillville, Indiana between representatives of ICAADA and the credentialing boards of Michigan and Wisconsin. A reciprocity agreement was reached which became the foundation of what is now the International Certification & Reciprocity Consortium (IC&RC). IC&RC was incorporated in 1981 to become the first international substance use certification organization. ICAADA, along with the boards of Michigan and Wisconsin, laid the groundwork for what is now an internationally recognized organization that has 73-member credentialing boards worldwide, representing over 35,000 certified addiction professionals from 41 states, Canada, Germany, Sweden, Puerto Rico, as a well as several branches of the armed forces.

For fifty years, ICAADA has been committed to public protection through the establishment of quality, competency-based certification programs for professionals engaged in the prevention, treatment and recovery of behavioral health concerns. ICAADA continues to be an industry leader on the state, national and international levels related to behavioral health certification.

# **Credential Overview**

ICAADA credentials support beginning, continuing, or advancing a career in behavioral health. ICAADA credentials are highly recognized in Indiana and many offer reciprocity in other states that have an IC & RC affiliate board. ICAADA is an approved credentialing body by the Indiana Division of Mental Health and Addiction (IDMHA) and a founding member of the International Credentialing and Reciprocity Consortium (IC&RC).








Figure 2 shows the count of CPS-A credentials by county in Indiana. Making a total of 14 CPS-A credentials across Indiana.




Figure 4 shows the total of CPS-A Credentials based on Age and Sex.




Figure 5 shows the count per education type for CPS-A credentials.




Figure 6 Shows the count of CPS credentials by county in Indiana. Making a total of 41 CPS credentials across Indiana.




Figure 8 shows the total of CPS credentials based on Age and Sex.




Figure 9 shows the count per education type for CPS credentials.

This credential is recognized by International Credentialing and Reciprocity Consortium (IC&RC) and IC&RC affiliated states and countries that offer the IC&RC CPS II credential. 


Figure 10 Shows the count of CPS II credentials by county in Indiana. Making a total of 9 CPS II credentials across Indiana.




Figure 12 shows the total of CPS II credentials based on Age and Sex.




Figure 13 shows the count per education type for CPS II credentials.



### **Treatment Credentials**

Addiction Consultant in Training (ACIT) is an entry level addiction treatment credential for individuals employed in the addiction treatment field or enrolled as a college student in addiction treatment studies. ACIT is a non-renewable credential and a steppingstone to other addiction professional credentials such as a CADAC.




Figure 15 Shows the count of ACIT credentials by county in Indiana and outside. There is a total of 67 ACIT credentials and of those, 93% are in Indiana and the remaining 7% in the following states: Kentucky, Michigan, Ohio, and Texas.




Figure 17 shows the total of ACIT credentials based on Sex and Age.





Figure 18 Figure 19 shows the count per education type for ACIT credentials.






Figure 21 shows the total of ACIT II credentials based on Age and Sex.




Figure 22 shows the count per education type for ACIT II credentials.




Figure 23 is the combined percentage of total ACIT and ACIT II credentials (blue bars) compared to the total credentials issued (TCI=) for that year.




Figure 24 shows the count of BCPG per Indiana County. Making a total of 11 BCPG credentials across Indiana.




Figure 26 shows the total of BCPG credentials based on Age and Sex.




Figure 27 shows the count per education type for BCPG credentials.








Figure 31 shows the total of CADAC I credentials based on Age and Sex.





Figure 32 shows the count per education type for CADAC I credentials.






Figure 35 shows the total of CADAC II credentials based on Age and Sex.





Figure 36 shows the count per education type for CADAC II credentials.




Figure 39 shows the total of CADAC III credentials based on Age and Sex.




Figure 40 shows the count per education type for CADAC III credentials.






Figure 43 shows the total of CADAC IV credentials based on Age and Sex.




Figure 44 shows the count per education type for CADAC IV credentials.






Figure 47 shows the total of CADAC V credentials based on Age and Sex.




Figure 48 shows the count per education type for CADAC V credentials.




Figure 49 is the percentage of total CADAC I-V credentials (blue bars) compared to the total credentials issued (TCI=) for that year.






Figure 52 shows the total of CCJP credentials based on Age and Sex.




Figure 53 shows the count per education type for CCJP credentials.








Figure 57 shows the total of MATS credentials based on Age and Sex.




Figure 58 shows the count per education type for MATS credentials.





Figure 59 is the percentage of total MATS credentials (blue bars) compared to the total credentials issued (TCI=) for that year.






Figure 62 shows the total of CPRC-A credentials based on Age and Sex.




Figure 63 shows the count per education type for CPRC-A credentials.

Certified Peer Recovery Coach (CPRC) is an experienced level credential for those who are in personal lived experience of recovery from substance use, mental health, or co-occurring disorders. This credential is for those who wish to provide recovery support to those seeking/in recovery from substance use and/or mental health concerns. This peer recovery support credential is recognized by the Indiana Division of Mental Health and Addiction and Indiana Department of Workforce Development as Promoted Industry Certifications. This credential is a billable option through Indiana Medicaid, Indiana Recovery Works and Indiana Problem Gambler Awareness Program. This credential meets the International Credentialing & Reciprocity Consortium requirements for the Peer Recovery (PR) credential.






Figure 66 shows the total of CPRC credentials based on Age and Sex.




Figure 67 shows the count per education type for CPRC credentials.






Figure 69 shows the count of CRC per Indiana county, making a total of 57 CRC credentials across Indiana.




Figure 71 shows the total of CRC credentials based on Age and Sex.




Figure 72 shows the count per education type for CRC credentials.








Figure 76 shows the total of CCS credentials based on Age and Sex.




Figure 77 shows the count per education type for CCS credentials.




Figure 78 is the percentage of total CCS credentials (blue bars) compared to the total credentials issued (TCI=) for that year.




Figure 79 shows the count of CSPR-CL credentials per Indiana county. Making a total of 10 CSPR-CL credentials across Indiana.




Figure 81 shows the total of CSPR-CL credentials based on Age and Sex.




Figure 82 shows the count per education type for CSPR-CL credentials.






Figure 85 shows the total of CSPR-PR credentials based on Age and Sex.




Figure 86 shows the count per education type for CSPR-PR credentials.




Figure 87 is the percentage of total CSPR-CL and CSPR-PR credentials (blue bars) compared to the total credentials issued (TCI=) for that year.




Figure 88 shows the total of CRC-MH per Indiana county, making a total of 2 CRC-MH endorsements in one Indiana County.




Figure 90 shows the total of CRC-MH credentials based on Age and Sex.




Figure 91 shows the count per education type for CRC-MH credentials.




Figure 92 shows the total of CRC-FS per Indiana county, making a total of 2 CRC-FS Endorsements across Indiana.




Figure 94 shows the total of CRC-FS credentials based on Age and Sex.




Figure 95 shows the count per education type for CRC-FS credentials.






Figure 98 shows the total of CPRC A-MH endorsements based on Age and Sex.




Figure 99 shows the count per education type for CPRC A-MH endorsements.




Figure 100 shows the count of CPRC-MH endorsements per Indiana county, making a total of 54 CPRC-MH endorsements across Indiana.




Figure 102 shows the total of CPRC-MH credentials based on Age and Sex.




Figure 103 shows the count per education type for CPRC-MH endorsements.




Figure 104 shows the count of CPRC A-GS endorsement per Indiana county, making a total of 2 CPRC A-GS across Indiana.




Figure 106 shows the total of CPRC A-GS endorsements based on Age and Sex.




Figure 107 shows the count per education type for CPRC A-GS endorsements.




Figure 108 shows the count of CPRC-GS endorsement per Indiana county. Making a total of 6 CPRC-GS endorsements across Indiana.




Figure 110 shows the total of CPRC-GS endorsement based on Age and Sex.




Figure 111 shows the count per education type for CPRC-GS endorsements.




Figure 112 shows the count of CPRC A-FS endorsement per Indiana county. Making a total of 2 CPRC A-FS endorsements across Indiana.




Figure 114 shows the total of CPRC A-FS endorsements based on Age and Sex.




Figure 115 shows the count per education type for CPRC A-FS endorsements.






Figure 118 shows the total of CPRC-FS endorsements based on Age and Sex.




Figure 119 shows the count per education type for CPRC-FS endorsements.

## **Summary**

- Increased partnership with service provider Adult & Child
