

Introduction

ICAADA, a subsidiary of Mental Health America of Indiana, provides certifications for behavioral health professionals. ICAADA provides behavioral health professionals with certifications, membership, and advocacy that validate the professionals' competencies to provide person-focused, evidence-based behavioral health services.

ICAADA was first formed in September 1973 by a group of dedicated and forward-looking substance use professionals. ICAADA started as an association of substance use professionals and people interested in the field. It was quickly decided there needed to be a process designed to establish a certification that would certify a person's competency relates to substance use treatment.

ICAADA is Indiana's longest tenured substance use certification organization. In 1976, with the cooperation of what was then the Department of Mental Health, Division of Addictions Services, ICAADA began the process of certification with the first certification being the Certified Alcohol Counselor (CAC). In 1977, a second certification, the Certified Drug Counselor (CDC), was established. In 1978, ICAADA established the Certified Alcohol & Drug Abuse Counselor (CADAC) certification (now known as the Certified Alcohol and Drug Addiction Consultant).


In 1979, a meeting was held in Merrillville, Indiana between representatives of ICAADA and the credentialing boards of Michigan and Wisconsin. A reciprocity agreement was reached which became the foundation of what is now the International Certification & Reciprocity Consortium (IC&RC). IC&RC was incorporated in 1981 to become the first international substance use certification organization. ICAADA, along with the boards of Michigan and Wisconsin, laid the groundwork for what is now an internationally recognized organization that has 73-member credentialing boards worldwide, representing over 35,000 certified addiction professionals from 41 states, Canada, Germany, Sweden, Puerto Rico, as well as several branches of the armed forces.


For fifty years, ICAADA has been committed to public protection through the establishment of quality, competency-based certification programs for professionals engaged in the prevention, treatment and recovery of behavioral health concerns. ICAADA continues to be an industry leader on the state, national and international levels related to behavioral health certification.


Certification Overview

ICAADA certifications support beginning, continuing, or advancing a career in behavioral health. ICAADA certifications are highly recognized in Indiana and many offer reciprocity in other states that have an IC & RC affiliate board. ICAADA is an approved credentialing body by the Indiana Division of Mental Health and Addiction (IDMHA) and a founding member of the International Credentialing and Reciprocity Consortium (IC&RC).

Total ICAADA Certifications Per County












Figure 3 shows the total amount of exams administered per exam type between 1/1/2025 and 1/1/2026.

Passing Percentage Per Exam




Figure 4 is the passing rate per exam for 1/1/2025-1/1/2026.

Certified Prevention Specialist-Associate (CPS-A) is a certification for prevention professionals which is recognized in Indiana only. This is an entry-level certification for prevention professionals to validate their competencies in substance use prevention and to support workforce development in the prevention field.




Figure 5 shows the count of CPS-A certifications by county in Indiana. 14 total CPS-A certifications are currently issued across Indiana.




Figure 7 shows the total of CPS-A certifications based on age and sex.




Figure 8 shows the count per education type for CPS-A certifications.

Total CPS Certifications Per County






Figure 11 shows the total of CPS certifications based on age and sex.




Figure 12 shows the count per education type for CPS certifications.

This certification is only recognized in Indiana and is meant to be a professional development certification for experienced CPS. This certification holder must currently possess the ICAADA Certified Prevention Specialist (CPS) certification.





Figure 13 shows the count of CPS II certifications by county in Indiana. 10 total CPS II certifications are currently issued across Indiana.

Count of Highest Level of Education of CPS II Certifications




Figure 16 shows the count per education type for CPS II certifications.

Total CPS-A, CPS, and CPS II Certifications Issued by Year



ACIT is a non-renewable certification and a steppingstone to other addiction professional certifications such as a CADAC.

Total ACIT Certifications Per County







Figure 20 shows the total of ACIT certifications based on age and sex.




Figure 21 shows the count per education type for ACIT certifications.

Addiction Consultant in Training – II (ACIT II) is an entry-level addiction treatment certification for qualified applicants who are seeking or employed in Opioid Treatment Programs (OTP). This certification is a Medicaid billable certification in OTP's when paired with the ICAADA MATS certification. The certification is non-renewable and certification holders are expected to obtain a CADAC II or higher by the expiration date of the certification.

Total ACIT II Certifications Per County






Figure 24 shows the total of ACIT II certifications based on age and sex.




Figure 25 shows the count per education type for ACIT II certifications.

Total ACIT and ACIT II Certifications Issued by Year



Total BCPG Certifications Per County






Figure 29 shows the total of BCPG certifications based on age and sex.




Figure 30 shows the count per education type for BCPG certifications.

Total BCPG Certifications Issued by Year








Figure 34 shows the total of CADAC I certifications based on age and sex.





Figure 35 shows the count per education type for CADAC I certifications.

Total CADAC II Certifications Per County








Figure 38 shows the total of CADAC II certifications based on age and sex.




Figure 39 shows the count per education type for CADAC II certifications.

Candidates seeking the CADAC III must hold and maintain a non-clinical (bachelor's level) license recognized by the Indiana Professional Licensing Agency (IPLA) Behavioral Health and Human Services Licensing Board.







Figure 42 shows the total of CADAC III certifications based on age and sex.

Count of Highest Level of Education of CADAC III Certifications




Figure 43 shows the count per education type for CADAC III certifications.






Figure 46 shows the total of CADAC IV certifications based on age and sex.









Figure 50 shows the total of CADAC V certifications based on age and sex.




Figure 51 shows the count per education type for CADAC V certifications.

Total CADAC I-V Certifications Issued by Year




Medication Assisted Treatment Specialist (MATS) is a treatment certification that provides validation of additional competency related to the medications utilized to treat substance use disorders. This certification is recognized by the Division of Mental Health and Addiction of the Indiana Department of Family and Social Services Administration. When paired with the ICAADA ACIT II certification for those who work, specifically, in Opioid Treatment Programs is approved for Medicaid Reimbursement.

Total MATS Certifications Per County








Figure 55 shows the total of MATS certifications based on age and sex.




Figure 56 shows the count per education type for MATS certifications.

Total MATS Certifications Issued by Year





Figure 57 is the combined total of MATS certifications (blue bars) compared to the total certifications issued (TCI=) for that year.

Recovery Certifications

Certified Peer Recovery Coach-Associate (CPRC-A) is an introductory level certification for those who have personal lived experience of recovery from substance use, mental health, or co-occurring disorders. This certification is for those who wish to provide recovery support to those seeking/in recovery from substance use and/or mental health concerns. Total CPRC-A Certifications Per County








Figure 60 shows the total of CPRC-A certifications based on age and sex.






Figure 61 shows the count per education type for CPRC-A certifications.

Total CPRC Certifications Per County








Count of Highest Level of Education of CPRC Certifications




Figure 65 shows the count per education type for CPRC certifications.

Average Recovery Time and Age by Gender Among Peer Recovery Coach Certifications






Figure 67 shows the count of CRC-A certifications by county in Indiana. 26 total CRC-A certifications are currently issued across Indiana.




Figure 69 shows the total of CRC-A certifications based on age and sex.




Figure 70 shows the count per education type for CRC-A certifications.




Figure 71 shows the count of CRC certifications by county in Indiana. 3 total CRC certifications are currently issued across Indiana.




Figure 73 shows the total of CRC certifications based on age and sex.




Figure 74 shows the count per education type for CRC certifications.

Total CFRC-A Certifications Per County






Figure 78 shows the count per education type for CFRC-A certifications.




Figure 79 shows the count of CFRC certifications by county in Indiana. 2 total CFRC certifications are currently issued across Indiana.




Figure 82 shows the count per education type for CFRC certifications.

Total CPRC-A, CPRC, CRC-A, CRC, CFRC-A, and CFRC Certifications Issued by Year








Figure 86 shows the total of CCS certifications based on age and sex.




Figure 87 shows the count per education type for CCS certifications.

Total CCS Certifications Issued by Year




Figure 88 is the combined total of CCS certifications (blue bars) compared to the total certifications issued (TCI=) for that year.






Figure 91 shows the total of CSPR-CL certifications based on age and sex.




Figure 92 shows the total of CSPR-CL certifications based on age and sex.

Total CSPR-PR Certifications Per County






Figure 95 shows the total of CSPR-PR certifications based on age and sex.




Figure 96 shows the count per education type for CSPR-PR certifications.

Total CSPR-PR and CSPR-CL Certifications Issued by Year




Figure 97 is the combined total of CSPR-PR and CSPR-CL certifications (blue bars) compared to the total certifications issued (TCI=) for that year.




Figure 98 shows the count of CPRC A-FS certifications by county in Indiana. 3 total CPRC A-FS certifications are currently issued across Indiana.


CPRC A-FS Certifications By Sex


Figure 100 shows the total of CPRC A-FS certifications based on age and sex.


Count of Highest Level of Education of CPRC A-FS Certifications


Figure 101 shows the count per education type for CPRC A-FS certifications.







Figure 104 shows the total of CPRC-FS certifications based on age and sex.




Figure 105 shows the count per education type for CPRC-FS certifications.

Total CRC A-FS Certifications Per County




Figure 106 shows the count of CRC A-FS certifications by county in Indiana. 3 total CRC A-FS certifications are currently issued across Indiana.





Figure 108 shows the total of CRC A-FS certifications based on age and sex.




Figure 109 shows the count per education type for CRC A-FS certifications.

Total Forensic Support (FS) Certifications Issued by Year






Figure 111 shows the count of CPRC A-GS certifications by county in Indiana. 2 total CPRC A-GS certifications are currently issued across Indiana.




Figure 113 shows the total of CPRC A-GS certifications based on age and sex.




Figure 114 shows the count per education type for CPRC A-GS certifications.

Total CPRC-GS Certifications Per County







Figure 117 shows the total of CPRC-GS certifications based on age and sex.




Figure 118 shows the count per education type for CPRC-GS certifications.

Total CRC A-GS Certifications Per County




Figure 119 shows the count of CRC A-GS certifications by county in Indiana. 1 total CRC A-GS certification is currently issued within Indiana.

CRC A-GS Certifications By Sex




Count of Highest Level of Education of CRC A-GS Certifications


Figure 122 shows the count per education type for CRC A-GS certifications.


Total Gambling Support (GS) Certifications Issued by Year






Figure 126 shows the total of CPRC A-MH certifications based on age and sex.




Figure 127 shows the count per education type for CPRC A-MH certifications.

Total CPRC-MH Certifications Per County






Figure 130 shows the total of CPRC-MH certifications based on age and sex.




Figure 131 shows the count per education type for CPRC-MH certifications.

Total CRC A-MH Certifications Per County




Figure 132 shows the count of CRC A-MH certifications by county in Indiana. 2 total CRC A-MH certifications are currently issued within Indiana.

CRC A-MH Certifications By Sex




Figure 134 shows the total of CRC A-MH certifications based on age and sex.

Count of Highest Level of Education of CRC A-MH Certifications




Figure 135 shows the count per education type for CRC A-MH certifications.

Total Mental Health (MH) Certifications Issued by Year



Summary

ICAADA has continued to reinforce the creation, strengthening and advancement of the certified behavioral health workforce through various efforts. Ensuring that certified ICAADA professionals are adequately trained, equipped to meet the needs of those they serve, and able to adapt to the changing workforce is crucial. The data in this report highlights the outcomes of these efforts and the value they contribute to Indiana's behavioral health workforce. These achievements are possible through the continued work, advocacy, and collaborative partnerships at both the state and national levels.

Specific efforts to highlight in 2025 include:

- The debut of the 'Certified Family Recovery Coach – Associate (CFRC-A)' and 'Certified Family Recovery Coach (CFRC)' certifications. These certifications allow for family members of someone who may or may not be seeking and/or in recovery from substance use, mental health, and/or co-occurring disorders and do not themselves have personal lived experience of recovery from substance use, mental health, or co-occurring concerns, to provide recovery support to family members or those seeking/in recovery from substance use and/or mental health concerns.
- Updates to the 'Certified Recovery Coach – Associate (CRC-A)' and 'Certified Recovery Coach (CRC)' certifications to better align with naming conventions and current workforce needs.
- Creation of 'Scope of Practice' documents for each ICAADA certification to support the associated ethical and professional responsibilities.
- Updates to the Medication Assisted Treatment Specialist (MATS) skills domains and examination.
- Partnership with the Indiana Department of Corrections (IDOC) to certify those currently housed within IDOC as CPRC-A's.
- Partnership with Northeast Indiana Area Health Education Center (NEI-AHEC) to certify eligible candidates with their recovery coach certification.
- The Department of Workforce Development (DWD) recognized the Certified Prevention Specialist (CPS) certification as an "Industry Promoted Certification."
